Iceland makes the following recommendations:

- 1. Fully abolish the death penalty and ratify the Second Optional Protocol to the ICCPR.
- 2. Immediately release unlawfully detained persons and enable an independent, transparent and impartial international investigation into all allegations of torture, sexual and gender-based violence and other ill-treatment of detained persons.
- 3. Ensure the right of people to peaceful assembly and the ability to peacefully protest, without limiting the rights of all participants, including LGBTI+ people.
- 4. Repeal laws and policies on mandatory testing for HIV, policies requiring health-care providers to reporting certain groups to law enforcement, and criminalization of HIV transmission.
